

Information sheet for Student visas

Foreign nationals can study in Switzerland for a period of up to 3 months without a student/residence permit. However, if their stay exceeds 3 months within one year a permit has to be applied for.

The application has to be submitted to the Swiss Embassy which will forward it to the competent authorities, in Switzerland Application forms are available <u>free of charge</u> at the Embassy of Switzerland and on the website as well.

Requirements:

<u>General</u>

- □ Completion of the visa application form in **triplicate**, personally signed by the applicant. Three passport-size photographs must be **pasted** on the forms
- □ Copies of the Machine Readable Passport

Intention of stay in Switzerland

- □ Curriculum vitae including an explanation of the intentions of the applicant in Switzerland and the future plans after the end of the study.
- □ Proof of academic qualification (Certificates, diplomas)
- □ An attestation from the school/college/university in Switzerland (acceptance letter)
- □ Type-written declaration by the applicant stating that he/she will return to Bangladesh on the completion of his/her studies
- □ Both new and old passport needs vice-versa connection from the Passport Office with their endorsement stamp.

Proof for covering the cost of living during the stay in Switzerland

- □ Affidavit/covering letter on business letterhead from the sponsor stating that he/she would bear the study expenses
- □ Evidence of financial resources (Bank statement/Certificate, Income-Tax papers, Fixed Deposit Receipts) of the applicant or the person who sponsors his/her education for the last year
- Letter from the bank confirming that the loan (if any) has been sanctioned
- □ Receipt of payment of school fees from Switzerland

NEW IMPORTANT Language Knowledge

- Confirmation of the school/college/university/ in Switzerland that you passed a Language test and have enough skills to follow the intended courses
- □ Result of the Language test

All documents must be submitted in original and three copies
